Recent Litigation Victories for NSLS Disability Attorneys

Rezwanul Islam, Senior Staff Attorney, Disability Advocacy Project, recently received a decision from the United States District Court, Eastern District, in <u>Gardner v Colvin</u> overturning a determination by the Commissioner of the Social Security Administration. The decision had held that his client had "the residual functional capacity to perform a full range of work at all exertional levels, with certain nonexertional limitations" and that "there were a significant number of jobs in the national economy that plaintiff could perform despite these limitations" and, therefore, he was not disabled.

In remanding the matter to the Administrative Law Judge who made the original decision, the Court found that she failed to properly evaluate the medical evidence and failed to fully develop the record. On remand, the ALJ was directed to consider the psychotherapy notes and the IEP and elicit further testimony from the plaintiff regarding her learning disability in order to fully develop the record.

In another recent case, Mr. F, a 51-year-old man at the time of his application, with an 11th grade education, applied for SSI in 2012 based on low IQ, inability to read, degenerative disc disease, knee pain and asthma. At a hearing held



in 2014, the client was represented by **Diane McClernon, Esq.** of the DAP Unit, where the ALJ issued an unfavorable decision. The judge found him capable of medium level work (ability to lift 50 pounds occasionally) and only briefly mentioned Mr. F's low IQ and did not even evaluate it in the decision. The ALJ also discredited the claimant's treating doctor's opinion. Diane took the case to the Appeals Council in 2015, which declined to remand the case. But Ms. McClernon did not give up and in November 2015, she filed an appeal in Federal Court. She argued that the ALJ failed to apply the "treating physician" rule; failed to develop the record, failed to specify the basis for the Residual Functional Capacity given, and failed to acknowledge the IQ score and deficits in adaptive functioning.

While the case was pending in Federal Court, Mr. F applied for

Nora Gonzalez awarded Fair Hearing of the Month by the Empire Justice Center

Her efforts avoided a 90-day sanction of public benefits



After the Department of Social Services (DSS) conducted an alcohol and substance abuse assessment for Mr. L. who was in receipt of public assistance, he was deemed to be in need of treatment but was able to work. When he did not appear at the intake interview, he was notified that his Assistance would be discontinued for 90 days. Mr. L sought the help of paralegal, Nora Gonzalez who requested a Fair Hearing on his behalf.

At the hearing, Nora argued that pursuant to DSS directive 99 INF-4, drug and alcohol treatment must be listed as part of an Employment Plan, as defined in 18 NYCRR 385.7(b)(1) and (2). DSS never presented the Employability Plan mandating attendance in the drug and alcohol programs. Since the treatment was not specifically listed, Nora argued that a sanction for non-compliance could not be imposed. She also maintained that the sanction notice was defective because it failed to state the specific instance of non-compliance. Nora prevailed on her client's behalf and DSS was ordered to continue Appellant's Safety Net assistance. Congratulations, Nora, for the expert advocacy and Fair Hearing of the Month award!

SSI in October 2015. That subsequent application was approved in December 2015. After that approval, Mr. F. moved out of state to live with his son. The case in Federal Court was recently remanded back for a hearing. The hearing was held by phone conference in May 2019, with the judge stating from the bench that he was awarding benefits back to the original filing date of 2012 up until the approved subsequent application. A great win for the client and a proud victory for his legal representative! Congratulations!

Senior Citizens Protected from Adult Child's Exploitation

In November 2018, when an elderly couple failed to pay their rent in full due to a Section 8 rental increase from \$575 to \$1467, the landlord commenced eviction proceedings to remove them. The couple lived on a fixed income and had lived in the subsidized housing for the past 35 years. The Section 8 agency increased the rent due to the employed adult daughter's earnings, but she refused to contribute to the household's expenses.

When the elderly couple failed to show up in court, the landlord got a judgment and the couple was served with a sheriff's 72-hour notice. The clients filed an order to show cause on their own and then turned to NSLS' Senior Citizen Project to represent them in a week and a half!

Rose Caputo, attorney in the Senior Citizen Project, represented them in court and reached a settlement to pay the landlord any arrears owed and to vacate two months later. Though the clients looked for alternative housing, they could not find anything affordable. The situation was made worse by Section 8 regulations prohibiting them from transferring their voucher to another rental unless the daughter was removed as a member of the household. She refused to leave voluntarily and began to verbally abuse her mother, throwing rocks at her window and posting disparaging facts about the clients on social media. Rose filed an order of protection alleging harassment by the clients' daughter and financial exploitation of her elderly parents. Though the daughter initially said she did not care if her parents became homeless, she consented to an order of protection in Family Court.

With the order issued, Section 8 granted a new voucher removing the daughter from the household budget. The clients were able to get assistance to pay



the rent arrears from a local pastor and the landlord located a one-bedroom apartment for the couple in the same complex. A very happy ending for this elderly couple. Kudos to Rose Caputo for all her hard work!



The Suffolk County Access to Justice Committee recently hosted a delegation from Georgia representing a sister "justice for all" project. The local collaborative and our out-of-state partners, share a strong commitment to expanding

access to justice in their communities. Personnel from the Georgia Dougherty County Law Library project were joined by staff from the National Center for State Courts as they met during the week of June 17,2019 with Suffolk Access to Justice partners. The Georgia pilot project, which also received access to justice funding, is focusing on rural legal services. The teams shared their ideas, challenges and goals at a series of meetings during which the Georgia staff visited the Cohalan Court complex, the Suffolk County Bar Association, Touro Law Center (photo above), and Suffolk public libraries.

The Suffolk Access to Justice Committee was formed last year as a result of input from Suffolk stakeholder agencies. The goal is to meet the community's legal needs and close the justice gap by providing meaningful access to justice for all. "Access" can included direct and indirect legal assistance through a wide range of legal services and comprehensive collaboration among legal services providers. **Nassau Suffolk Law Services** has joined other community organizations and legal service providers to achieve this goal (more on p. 7).

Changes in the Law You Should Know About

- The new rule on **Public Charge** goes into effect on October 15, 2019. It will create significant additional barriers for those trying to adjust their immigration status to Lawful Permanent Residence through Family Petitions. - Landlord Tenant Law saw drastic changes in the law that occurred suddenly this summer. As the legal community is quickly getting up to speed, be aware that there is a dramatic impact on predicate notices to tenants (much more lead time in most cases), including the format and timing of the notice, mandatory adjournments, elimination



of attorneys fees in some cases, service and return dates, and sheriffs' warrants. Published on our website at <u>www.nslawservices.org</u>

• Americans with Disabilities Act litigation: The Empire Justice Center and the National Center for Law and Economic Justice filed a Class Action Complaint yesterday in federal court against Frances Pierre, Commissioner of the Suffolk County Department of Social Services (Suffolk County DSS), on behalf of Suffolk County residents with disabilities who need accommodations to access public benefits and participate in programs administered by Suffolk County DSS, such as Medicaid, SNAP (commonly known as Food Stamps), Temporary Assistance, and Temporary Housing Assistance. The Complaint alleges that Suffolk County DSS, as administered by Commissioner Pierre, violates the Americans with Disabilities Act and Section 504 of the Rehabilitation Act of 1973 by discriminating against people with disabilities. Specifically, the allegations include a systemic failure or refusal to provide the accommodations necessary for individuals like Plaintiffs to access and maintain benefits and services.
